AUSTRALIA DAY QUIZ - Terms and Conditions

How well do you know Australia?

In celebration of Australia Day (26 January), the Australian High Commission, Colombo will be holding an Australia Day Quiz to test your knowledge of Australia!

We invite all Sri Lankan citizens or permanent residents, aged 18 or over and current Sri Lankan residents to enter.

HOW IT WORKS

The Australia Day Quiz will run from 19th January to 25th January 2021 our Facebook page (@AustraliainSriLankaandMaldives).

Each day, at 9.00am one question will be published to the Facebook page. Participants have until 4.00pm that same day to answer the question.

To be into win, participants will need to:

- Follow the Facebook page (@AustraliainSriLankaandMaldives) by clicking the 'Like' button below the cover photo; and
- Answer the question correctly by commenting on the post.

Entry is free.

Participants are encouraged to answer as many questions as they like (although they can only answer each question once!).

PRIZES

Those that answer correctly each day will go into a draw to win either first place, second or third place prizes.

Winners will be chosen randomly.

The winners of the daily prizes together with the correct answer will be announced on the Facebook page (@AustraliainSriLankaandMaldives) each day after 4.00pm.

WHO CAN ENTER

To be eligible for the quiz, participants must:

- 1. Be a Sri Lankan citizen or Sri Lankan permanent resident, currently residing in Sri Lanka;
- 2. Be aged 18 or over as at the date of entering the Quiz; and
- 3. Follow us on our Facebook Page.

TERMS AND CONDITIONS OF ENTRY

IMPORTANT: PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY BEFORE ENTERING THE AUSTRALIA DAY QUIZ.

Introduction

- 1. The Australia Day Quiz ("Quiz") is organised by the Australian High Commission, Colombo (AHCSL).
- 2. These terms and conditions establish the parameters under which you are entitled to participate in the Quiz. By entering the Quiz, you confirm you have read, understood and agree to abide by, these terms and conditions.

Eligibility

- 3. Subject to paragraph 3 below, the Quiz is open to all Sri Lankan citizens and Sri Lankan permanent residents who meet the following criteria:
 - a) are aged 18 or over as at time of entering the Quiz: and
 - b) follow and like Australia in Sri Lankan and Maldives on its Facebook Page (...link...).
- 4. Employees of AHCSL or its attached agencies and/or their immediate family members may not enter the Quiz. Immediate family member means spouse, defacto partner, children, grandchildren, parents, grandparent and/or siblings (and their spouses).
- 5. AHCSL reserves the right to verify the eligibility of each entrant and to exclude and/or disqualify participants if they:
 - a) do not meet the requirements set out in paragraph 1 or 2 above;
 - b) breach these terms and conditions; and/or
 - c) are in AHCS's view, likely to bring AHCSL into disrepute.

Quiz Period

6. The Quiz will run from 9.00am Tuesday 19 January 2021 to 4.00pm, Monday 25 January 2021 "Quiz Period") and will be conducted on AHCSL's Facebook page (@AustraliainSriLankaandMaldives)

How to Enter

- 7. Entry to the Quiz is free.
- 8. To enter the Quiz, participants must answer questions correctly, which will be posted on AHCSL's Facebook page throughout the duration of the Quiz Period.
- 9. One question will be released at 9.00am each day of the Quiz Period on AHCSL's Facebook page. Participants have until 4.00pm that day to answer the question.
- 10. Answers must be submitted by commenting on AHCSL's post announcing the question.
- 11. Participants are only entitled to submit one answer per question, but can answer as many questions as they like throughout the Quiz Period.
- 12. Answers will be deemed to be accepted once published on AHCSL's Facebook page. AHCSL will not be responsible for any answer which is lost, late, incomplete or otherwise not received by AHCSL for any reason, including telephone connection failures, internet failures and disruptions, and ISP problems.
- 13. The correct answer will be posted by AHCSL on its Facebook page after 4.00pm each day of the Quiz Period.
- 14. Unless otherwise specified, AHCS will not be responsible for any costs Participants incur in entering this Quiz.

Prizes

- 15. The Prizes are given "as is" without any warranty and are not exchangeable for cash.
- 16. In the event the stated Prizes are, for any reason, unavailable, AHCSL reserves the right to substitute them with an alternative prize, without prior notice. AHCSL will make best endeavours to provide alternative prizes of an equivalent value.

17. Unless otherwise specified in these terms and conditions, the Prize winner and not AHCSL, will be responsible for any costs which may be associated with the award, acceptance, receipt or use of the Prizes, including the cost of making necessary travel arrangements to redeem the Prize.

How Prize winners are selected

- 18. Subject to paragraph 21 below, those participants who submit the correct answers to each question will go into a draw and picked at random to win a Daily Prize.
- 19. If a participant has previously won a Daily Prize, they will be excluded from winning another Daily Prize during the Quiz Period.
- 20. AHCSL's decisions as to the winners of the Prizes shall be final and AHCSL will not enter into any further correspondence in this respect.
- 21. In the event it is discovered after selection of a Prize winner that they do not meet the Quiz eligibility requirements or if they are subsequently disqualified by AHCSL, AHCSL will have the right to re-select a winner in accordance with these terms and conditions.

How winners will be notified

- 22. Daily Prize winners will be published by AHCSL on its Facebook page after 4.00pm each day during the Quiz Period by 'tagging' them in AHCSL' post, unless it is a weekend, in which case the Daily Prize winners will be published by AHCS on its Facebook page on the next business day.
- 23. AHCSL will also notify each Prize winner on Facebook Messenger within two business days of publishing the result. At this time, AHCSL will also seek their details (name, age) ("Personal Details") and contact details, to organise collection of the Prizes.
- 24. Prize winners must provide the Personal Details and contact details within five (5) business days of the request by AHCSL. If the winner fails to provide AHCSL with the requested details within this timeframe, they will forfeit their Prize and AHCS reserves the right to select another winner, in accordance with these terms and conditions.
- 25. For the avoidance of doubt, all correspondence will be deemed to be successful once recorded as sent by AHCSL and once received by AHCSL on its Facebook Page and/or computer records.
- 26. Apart from as specified in paragraphs 24 and 25 above, AHCSL will not be obliged to issue any reminder or further notification regarding the collection of the Prizes.

Each Quiz participant grants AHCSL the right to use his/her Personal Details, likeness, comments and/or Quiz content for promotional purposes without payment of additional consideration, except where prohibited by law. This includes but is not limited to announcing the result of the Quiz or publishing Prize winners on AHCSL's Facebook page.
